MS.RAHAT KAUNAIN HASSAN CHAIRPERSON COMPETITION COMMISSION OF PAKISTAN

Ms. Rahat Kaunain Hassan is the Chairperson of the Competition Commission of Pakistan (CCP) since July 26, 2010. Under her leadership, CCP has gained international repute for achieving substantive progress in competition law enforcement in a short span of time. Earlier, Ms. Hassan served CCP as Member (Legal and Office of Fair Trading) since its establishment in November 2007.

Ms. Hassan received LL.M. degree from King's College, London. She has been associated with, and has been a partner at, some of the finest civil and commercial law firms in Pakistan.

In 2001, Ms. Hassan was appointed General Counsel/Executive Director at the Securities and Exchange Commission of Pakistan (SECP). Soon after the conclusion of her tenure at SECP, Ms. Hassan established her own law firm, handling civil and commercial litigation and regulatory work. She was instrumental in the establishment of the Office of Fair Trading within CCP and has authored numerous position papers, guidelines, policy notes on important issues of competition law and policy. Moreover, she has authored, co-authored most

of the seminal Orders passed by CCP, including those that resulted in breaking the most pernicious of cartels.

Under her leadership, CCP has been twice nominated/short listed amongst top 5 agencies for GCR Enforcement 'Agency of the year Award' out of 42 agencies in the region of Asia Pacific Middle East and Africa, by the Global Competition Review — a UK based organization. Since 2010, CCP has been volunteering for GCR third party independent evaluation, wherein, CCP's performance has been termed as 'impressively consistent' and presently upon her request, CCP is undergoing 'Peer Review' by UNCTAD to assess and evaluate the impact of CCP's performance with recommendation of possible improvements.

A working mother of four, Ms. Hassan has been a high achiever in her field, and in recognition of her commitment to the public service, she received the prestigious 'Women of Achievement Award, 2010' and Wonder Women Award, 2013. She has also been nominated for the Sitara-e-Imtiaz.

DR. JOSEPH WILSON MEMBER COMPETITION COMMISSION OF PAKISTAN



With over 19 years experience of practice, teaching and research in regulatory laws, Dr. Wilson has been serving as Member at the Competition Commission of Pakistan since the Commission's establishment in 2007. He was responsible for the Monopolies and Trade Abuses Department for the first two years, and now oversees the Mergers & Acquisitions, and International Affairs Departments.

Prior to joining the Commission, he was an Associate Professor of Law at the Lahore University of Management Sciences (LUMS), Pakistan, where he taught "competition law" in addition to other courses. He has presented at various international conferences, published in international law journals and authored a book title "Globalization and the Limits of National Merger Control Laws (published by Kluwer Law International).

Before joining LUMS, Dr. Wilson taught at McGill's Faculty of Law, Montreal Canada, from where he earned Doctor of Civil Law (D.C.L.) with Deans Honour List and Masters of Law (LL.M.). He also holds an LL.M. from the University of Georgia, USA. He is a member of the State Bar of New York, USA and Lahore High Court Bar, and also serves on the International Advisory Board of the Loyola University Chicago's Institute for Consumer Antitrust Studies, USA.



MR. SHAHZAD ANSAR MEMBER COMPETITION COMMISSION OF PAKISTAN

Mr. Ansar is predominantly a private sector entrepreneur with over 27 years' in management, business development and project finance. Since February 2011, he is responsible for the activities of the Office of Fair Trading and Budgetary Affairs Department of the Commission.

Before joining the Commission, Mr. Ansar held the CEO positions at Furniture Pakistan, a subsidiary of Pakistan Industrial Development Corporation, a thermal power plant, and was the head at World Water Corporation USA for its operations in Pakistan. As a businessman, he managed two industrial units from their inception to full-scale operation. He has been actively involved in trading with companies based in Singapore, Malaysia, USA, Canada and China, and holds strong ties with international players in the energy and commodities sectors. He has also been involved in consultancy

projects in the fields of SME management, micro-financing and energy. He has substantial experience in dealing with international financial organisations such as the World Bank.

On the academic front, Mr. Ansar has been associated with the Virtual University (Ministry of Information Technology) as a resource person. MR. MUEEN BATLAY MEMBER COMPETITION COMMISSION OF PAKISTAN



Mr. Batlay, Member (Competition Policy and Research), has worked in the fields of investment banking, international development, consulting, education and public policy in Pakistan and overseas for over 20 years.

Mr. Batlay joined the Commission in January, 2011, and is focused on building the capacity of the Competition Policy and Research Department to enable the Commission to assist the government in shaping a Competition Policy that is in line with the true spirit of competition as envisioned in the Competition Act, 2010. In addition, he is strengthening the department's research capabilities to produce policy notes, competition assessments and regular publications to assist the Commission in its work.

Prior to joining the Commission, Mr. Batlay managed an investment advisory and a consulting firm, Capital Resource. His assignments included project finance, advisory and public private partnership projects at Samba Bank, Pakistan; private sector development, privatization, and capital market

development at the World Bank, USA; education policy and public schools system management for the city of Washington DC, USA; and economic reform management for the Government of Sindh. While at the World Bank, he advised the governments of Sri Lanka and Jordan in developing their privatization programmes and worked to strengthen capital markets globally. With the Government of Sindh, he channelled the efforts of multiple public private taskforces to develop and implement an economic reform program for the province. At Citibank, he worked on privatization advisory and on developing term finance certificates - the first corporate bonds of Pakistan. For Washington DC schools, he initiated the student tracking and database management programs.

Mr. Batlay holds a Master of Public Policy (MPP) with emphasis on international trade and finance from the Kennedy School of Government at Harvard University.



MR. MOHAMMED HAYAT JASRA SECRETARY COMPETITION COMMISSION OF PAKISTAN

Mr. Jasra was appointed as Secretary to the Commission on 12 November 2007, the date the Commission was established. Mr. Jasra holds Masters Degree in Economics and an L.L.B (Honours) degree. He is Fellow Member of the Institute of Cost and Management Accountants and is also Member of the Institute of Chartered Secretaries & Administrators, UK.

Mr. Jasra has an extensive experience of 26 years in different senior positions at Securities and Exchange Commission of Pakistan. He was working with SECP as its Secretary and also Executive Director (Law), when he sought retirement on personal grounds from SECP. Mr. Qureshi serves as both the Registrar and as Director General in the Commission. His current job responsibilities include serving as head of the Legal Department, managing the legal affairs of the Commission and to arrange the hearings and assist the adjudicating Members in Competition Law and other Legal matters. Earlier he was also entrusted with the additional charge of the Director General Office of Fair Trading. Under his able leadership, OFT has exposed the deceptive marketing practices of undertakings in the banking and the telecom sector. While acting as the Registrar/Director General (Legal) of the Commission, Mr. Qureshi supervises and manages all the litigation by or against the Commission before the Superior Courts in addition to finalizing the pleadings to be filed in the Courts. He also acts as a liaison officer at the Commission to interact with the Ministries and other Governmental and Regulatory Bodies. Mr. Qureshi has appeared before the August Supreme Court of Pakistan and Hon 'able Supreme Court and also represented the Commission before the Parliament in various matters and also during the phase of enactment of Competition Law in Pakistan.

A lawyer with keen insight, he has a nuanced understanding of the regulatory and business climate of Pakistan. His vast experience in drafting secondary legislation is another asset. Mr. Qureshi brings with him invaluable experience of having worked in the private and the public sector, including regulatory bodies such as the Securities and Exchange Commission of Pakistan (SECP). Mr. Qureshi within his passion for the improving the legal framework within the

organization played a pivotal role in establishing the Legal Department at SECP when he joined SECP in 2001. He has also worked as the Senior Legal Advisor to the Federal Government's Infrastructure Project Development Facility (IPDF). H.E. LARS-GUNNAR WIGEMARK

EU AMBASSADOR HEAD OF EU DELEGATION TO PAKISTAN

Ambassador Lars-Gunnar Wigemark is the Head of the European Union Delegation to Pakistan. He was born on March 20, 1960 in Göteborg, Sweden. He graduated from Harvard University in 1984 with an A.B. Magna Cum Laude in Social Science and holds a Master's Degree from the Fletcher School of Law and Diplomacy in International Law and Economics.

In 1988 he joined the Swedish Foreign Service in Stockholm and has been posted to Belgrade, Washington, Brussels, Kabul and Moscow, where he served as Deputy Head and Minister at the Swedish Embassy 2003-2007.

In 2008 Lars-Gunnar Wigemark was appointed Head of the Security Policy Unit in the European Commission and as of December 2010 he is working in the External Action Service of the European Union.

In September 2010 the European Union High Representative Catherine Ashton appointed Mr Wigemark as one of the first EU ambassadors under the Lisbon Treaty. He took up his new duties in Pakistan in early February 2011.

MR. EDUARDO PÉREZ MOTTA

CHAIRMAN

Mr. Perez Motta was appointed Chairman of the Mexican Federal Competition Commission (CFC) in September 2004.

In April 2012, he was designated Chairman of the International Competition Network (ICN), which brings together 127 competition agencies with the aim of addressing common antitrust and enforcement issues. Mr. Perez Motta also served as the ICN's Vice Chair for International Coordination for more than two years. From 2001-2004, he was Mexico's Ambassador to the World Trade Organization (WTO), where he was responsible for the organization of the Doha Ministerial Conference (2001) and the Mexican Chairmanship at Cancun in 2003.

From 1998 to 2000, he acted as head of the Ministry of Trade and Industrial Development's (SECOFI) Representation Office in Brussels, and coordinated the Mexican team during the negotiation of the Free Trade Agreement between Mexico and the EU.

He holds a bachelor's degree in economics from the Instituto Tecnológico Autónomo de México (ITAM), and a master in economics from the University of California at Los Angeles (UCLA). Mr. Perez Motta has taught microeconomics, international trade and competition policy at ITAM, El Colegio de México and Instituto Tecnológico y de Estudios Superiores de Monterrey, and is a member of the editorial board of Competition Policy International (CPI).

MR. RICHARD JANDA PROFESSOR MCGILL UNIVERSITY CANADA

Professor Janda teaches business associations, administrative law, competition law, economic regulation, and air transport regulation. He was Law Clerk to Justices Le Dain and Cory of the Supreme Court of Canada and is a past Director of the Centre for the Study of Regulated Industries at McGill. His main current research areas are the legal basis of domestic and global corporate social responsibility and the regulatory regimes governing domestic and global public goods.

Apart from his academic contributions, has been involved in work for the WTO, ICAO, OECD, the World Bank, a number of Canadian public agencies as well as work in a number of developing countries. In 2007, Richard Janda was appointed as Hydro Québec Scholar in Sustainable Development Law for an initial five-year term, which was renewed in 2012.

PROF. WILLIAM KOVACIC

PROFESSOR, GEORGE WASHINGTON UNIVERSITY USA



William Evan Kovacic served as a Commissioner of the Federal Trade Commission from January 4, 2006 to October 3, 2011, and served as Chairman of the agency from March 2008 to March 2009. Prior to his appointment as Commissioner, Kovacic was the E.K. Gubin Professor of Government Contracts Law at George Washington University Law School, where he began teaching in 1999. He previously taught antitrust law at George Mason University. He was the FTC's General Counsel from 2001 through the end of 2004. Kovacic earlier worked at the Commission from 1979 to 1983. first with the Bureau of Competition's Planning Office and later as an attorney advisor to former Commissioner George W. Douglas. After leaving the FTC in 1983, Kovacic was an associate with the Washington, DC, office of Bryan Cave, where he practiced in the firm's antitrust and government contracts departments, until joining the George Mason University School of Law in 1986.

Earlier in his career, he spent one year on the majority staff of the Subcommittee on Antitrust and Monopoly of the U.S. Senate Committee on the Judiciary, which was chaired by Senator Philip A. Hart. Since 1992, Kovacic has served as an adviser on antitrust and consumer protection issues to the governments of Armenia, Benin, Egypt, El Salvador, Georgia, Guyana, Indonesia, Kazakhstan, Mongolia, Morocco, Nepal, Panama, Russia, Ukraine, Vietnam, and Zimbabwe.

Professor Kovacic is the 2011 recipient of the Miles W. Kirkpatrick Award for Lifetime FTC Achievement, acknowledging how much of his professional career and personal passion he has devoted to the agency. SESSION 1

MS. GABRIELE HERLEMANN HEAD CHAMBER OF PUBLIC PROCUREMENT TRIBUNALS BUNDESKARTELLAMT GERMANY



Gabriele Herlemann studied law at the University of Munich and has a doctorate in law from the Max-Planck-Institute for Intellectual Property in Munich. She started to work as a lawyer in 1989 at the German Competition Authority, the Bundeskartellamt. After the reunification of Germany in 1989 she spent the years from 1991 to 1999 in the former eastern part of Germany, the German Democratic Republic, working in a ministry on state level in Schwerin, Mecklenburg-Vorpommern.

She was responsible for the implementation of public broadcasting in Mecklenburg-Vorpommern and also for the state supervision of public broadcasting. In 1999 she returned to the Bundeskartellamt where she worked in the field of competition law until 2000. After the public procurement tribunals had been established in the national German law at the Bundeskartellamt in 1999 according to the European Directives on public procurement, she started to work as a judge in one of the then two public procurement tribunals. When the third chamber of the public procurement tribunals was established in 2004, she became head of this chamber. She is currently working in this position.

MR. MANUEL SEBASTIÃO PRESIDENT PORTUGUESE COMPETITION AUTHORITY, PORTUGAL

Mr. Manuel Sebastião has been the President of the Portuguese Competition Authority since March 2008. Prior to this, he was Member of the Board of Directors, Bank of Portugal; Executive Director, Portuguese Insurance and Pension Funds Supervisory Authority; Advisor, Strategic Planning, Bank of Portugal; Executive Director of the Portuguese Trade and Development Bank (Banco de Fomento e Exterior, S.A., BFE Group), and Executive Director of the commercial bank of the BFE Group.

An economist, Mr. Sebastião has worked with the International Monetary Fund, Bank of Portugal, Portuguese Development Bank, and a consulting firm of the Portuguese

private group CUF. He was also the Chief of Staff to the Minister of Industry, and an advisor with the Ministry of Industry. Over the past twenty-five years, at various stages of his career, he was lecturer in economics at the Catholic University of Lisbon, the New University of Lisbon, and the business school ISCTE, also in Lisbon.

Mr. Sebastião holds an undergraduate degree in economics from the Technical University of Lisbon, Portugal, a graduate degree in economic planning from the University of Paris I, France, and a Ph.D. in economics from Columbia University, New York, USA

MR. JOHN M. CONNOR

EMERITUS PROFESSOR PURDUE UNIVERSITY USA



Now Emeritus Professor, he taught industrial-organization economics at Purdue University in Indiana from 1983 to 2011. He holds a bachelor's degree in mathematics from Boston College and a Ph.D. from the University of Wisconsin. From 1979 to 1983 he was head of Food Manufacturing Research in the Economic Research Service of U. S. Department of Agriculture.

Dr. Connor specializes in empirical research in industrial economics and antitrust policy; since 1997 the focus of his research has been international price-fixing cartels and world-wide enforcement of competition laws. He is the

author of 18 books and monographs and more than 200 other scholarly publications in economics and law. His book, Global Price Fixing, received two national writing awards in 2002 and 2003; new editions appeared in 2007 and 2008.

Dr. Connor is also Senior Fellow of the American Antitrust Institute (Washington, DC) and advisor to law firms in cartel cases. In 2009, his lifetime achievements were recognized when he was given the highest honor of the Agricultural and Applied Economics Association, the title of Fellow.

MR. FERNANDO FURLAN MANAGING PARTNER FURLAN ASSOCIATES BRAZIL

Fernando de Magalhães Furlan, 44, is managing partner at Furlan Associados, in Brasília. He was president of the Administrative Council of Economic Defense (CADE), Brazil (2011-2012), acting President of CADE (2010-2011), CADE Commissioner (2008-2011) and CADE general counsel/ attorney general (2001-2003), appointed for those positions by 3 different presidents of Brazil and approved by the Senate. Mr. Furlan was director/head of the Department of Trade Remedies (DECOM/SECEX) at the Ministry of Development, Industry and Foreign Trade of Brazil (2005-2008). From 2003 to 2005, he served as chief of staff for the Minister of State for Development, being also appointed acting Minister of State, Mr. Furlan seated as chairman of the auditing board of the Brazilian Agency for Industrial Development - ABDI (2004-2008). He was also member of the Board of the Special Agency for Industrial Financing (FINAME) of the National Bank for Economic and Social Development (BNDES) from 2005 to 2007.

Mr. Furlan served in several other professional and directive positions in the Brazilian public service, including the National Congress and the Brazilian Supreme Court; in law firms in the U.S. and Europe and in leading corporations in Brazil. Mr. Furlan received his Ph.D. degree (doctorat) from the University of Paris I – Panthéon Sorbonne (France) in 2006, where he also received his master's degree in 2000. He obtained his law degree from University of Brasilia (Brazil) in 1993 and his business administration degree from the University of Santa Catarina (Brazil) in 1991. From March to August/2012 Mr. Furlan was a post-doctoral research fellow under the project: "Settlements of Trade Disputes between China and Latin American Countries" at the Faculty of Law of the University of Macau, China. He is also member of the Dispute Settlement Body of MERCOSUR and is currently working for the United Nations (Unctad) as an ad hoc consultant in competition policy projects in Pakistan and in several Latin American countries.

MR. JOHN K. DAINA SENIOR ECONOMIST -ENFORCEMENT DIVISION COMPETITION AUTHORITY OF KENYA KENYA



Mr. John K. Daina is a holder of B.A Economics degree (Moi University) and a Diploma in Purchasing and Supply Management (the Chartered Institute of Purchasing and Supply, UK). He has been working with the Competition Authority of Kenya, in the position of a Senior Economist, Enforcement Division, since its establishment in August, 2011. Previously, he was working with the Monopolies and Prices Commission, since November, 2003. In addition, he worked as a Procurement Officer with various Ministries within the Government of Kenya, since 1998.

Mr. Daina has worked on a number of mergers, enforcement and exemption cases at the Competition Authority covering a wide range of industries including: alcoholic drinks, sports, horticultural, air transport, maize and maize flour and

mining. He has also participated enormously in the process of developing the strategy and systems of the new competition Authority of Kenya.

In addition, he contributed immensely in enactment of the EAC Common Market Protocol and also in the 2012, W.T.O. trade review process for the East Africa Community member states. Currently, he is part of a joint research team, organized by the African Competition Forum (ACF) to study the dynamics of Competition in the Cement sector in five countries (Kenya, South Africa, Zambia, Botswana and Tanzania).

MR. TIMOTHY T. HUGHES, J.D. ATTORNEY FEDERAL TRADE COMMISSION USA

Tim Hughes has been an attorney with the Federal Trade Commission for 28 years.
